6. A) The Author of the Trust hereby constitute, nominate and appoint the Board of Trustees consisting of himself and the second, third parties herein as the First members of the Board of Trustees.

7. Power of Managing trustee:
- a) Be the Chief executive of the Trust.
- b) Be in over all general control and charge of all the Institutions run, controlled and managed by the trust.
- c) Be responsible for due maintenance of all accounts and records of the Trust in accordance with the law that prevails in the place in which the Institution is constituted.
- d) Be entitled to pen, maintain and operate accounts in banks, financial Institutions and other types of Institutions dealing with finance in the name of the Trust.
- e) Be entitled to sign and endorse and authorize all negotiable instruments or other types of instruments drawn in favour of the Trust, in favour of anybody as may be required for the purpose of the Trust.

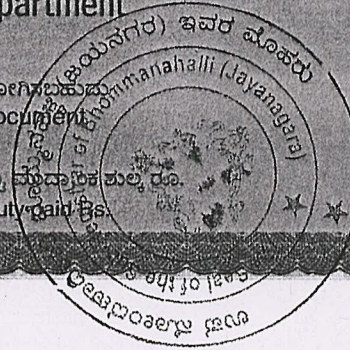

8. To engage, appoint administrators, C.E.Os, for assisting in the management of the trust. To appoint teachers, lectures, professors, instructors and experts of good moral character and conduct for imparting instructions to students in modern scientific, industrial, vocational, research work and other useful pursuits.
9. To promote the development of mental, physical, moral and spiritual upliftment of students and all those connected with the educational and other Institutions so as to make them good citizens of India.
10. To establish, maintain, run boarding houses, hostels and residential buildings for the students, teachers and other persons connected with the Institutions.
11. To establish and run paying guest hostels for college students and working men and women.
12. To bring out, encourage, develop, the research facilities of the students and provide opportunities and facilities for research work in art, science and industrial fields.
13. To pay out from income of the Trust, stipends and scholarships to poor and deserving students to pursue higher education.
14. Relief of poverty and distress of all kinds in India in the form of poor feeding, clothing and the like.
15. Rendering and affording of medical relief and aid in India and for the purpose aforesaid to open, establish, maintain control and conduct dispensaries, hospitals, nursing homes, maternity homes, sanatoriums and medical and first aid centres, ambulances and payment of medical bills.

- 17.To accept donations, grants, presents and other offerings and to utilize the same the purposes of the Trust and such donations shall be kept as part of the corpus of the Trust and shall not be treated as income of the Trust.
- 18.To invest, dispose of transfer of otherwise deal with trust properties as the trustees should deem fit so as to enable the Trust to carry on to achieve the objects of the trust effectively.
- 19.To establish, support and maintain community halls for the benefit of the public, provided however that the said Community Halls are run with no profit motives and made available to the general public without reference to caste/community, at a nominal cost for maintenance and upkeep of such Community Halls and to support other trust activities.
- 20.The Board of Trustees shall have the power from time to time to frame and alter such rules and regulations with regard to conduct of the business and all matters in respect of duty hereby vested in them as they may think fit.
- 21.The board of trustees shall be at liberty to add or alter or abrogate any of the provisions of the trust apart from the objects of the trust in a manner not inconsistent with the objects of the trust laid down in para(5) of the deed.
- 22.The Board of trustees are indemnified against any expenses and losses incurred or suffered or any payments made by them in the administration of the trust and such expenses, losses and payments shall be borne by the trust and none of the board trustees as the case may be shall in any way be personally liable responsible for the same.

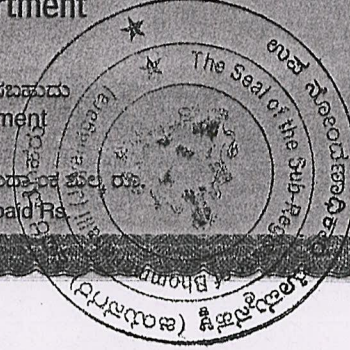

24. Nothing contained in this Deed shall be deemed to authorize the Trustees to do any act which may in way be constructed as violative or contrary to the provisions of section 2(13) 11, 12, 12A, 13 and or 80G of the Income Tax Act, 1961 or any statutory modification thereon and all activities of the trust shall be carried out with a view to benefit the public at large, without any profit motive and in accordance with the provisions of the Income Tax Act 1961 or any statutory modifications thereof.
25. The above objects are for the benefit of the general public without restriction to any religion, caste, class or sex.
26. This trust may be extinguished at any time with consent of managing trustee and if the majority of members of the board of trustees decide to so extinguish the trust upon extinction of the trust, the entire trust funds shall be realised and first be used for payment of liabilities of the trust and for meeting exopense4s of realization. The balance left, if any shall be donated to such institutions recognized u/s 80 G of the income tax Act, 1961 As amended from time to time as may be decided by the majority of the board of Trustees and to clear the debt of the trust if any.
27. The Trustees shall keep proper books of account and cause to record the receipts and payments and shall also maintain documents relating to these transactions. A Chartered Accountant who will be appointed by the Managing trustee/ Board of Trustee shall audit the accounts once in a year. The financial year shall be the accounting year of the Trust and the books of accounts of the Trust shall be closed on the 31st.
28. The funds and income of the trust shall be solely utilised for the achievement of its objects and no portion of it shall be utilised for payment to the trustees by way of profit, interest, dividend etc. However, any of the trustees here in, if appointed to a full time post of CEO or Administrator or Lecturer is eligible to receive the salaries/wages as per the market standards and instition standards prevailing from time to time.

29. The funds of the trust shall be invested in the modes specified under the provisions of section 13 (1) (d) read with section 11 (5) of the income tax Act, 1961 as amended from time to time.

Power to Borrow:
